### HEALTH CARE GROUPS APPLAUD NEW DRUG SHORTAGES LEGISLATION

*Expanded Authority for FDA among Recommendations  
from November Summit on Drug Shortages*

**Bethesda, Md.**— A group of leading healthcare organizations have expressed their strong support for the Preserving Access to Life-Saving Medications Act (S 296) as an important first step in addressing the complex issue of drug shortages. The legislation was introduced yesterday by Sens. Amy Klobuchar (D-Minn.) and Robert Casey (D-Pa).

The organizations, the American Society of Anesthesiologists (ASA), the American Society of Clinical Oncology (ASCO), the American Hospital Association (AHA), the American Society of Health-System Pharmacists (ASHP), and the Institute for Safe Medication Practices (ISMP), are leading efforts to implement recommendations from a November 2010 Summit convened to explore solutions that would prevent patient harm and minimize disruptions in care caused by drug shortages.

The Summit included participants from health professional organizations, pharmaceutical manufacturers, and supply chain entities. Representatives of the Food and Drug Administration (FDA) and other regulatory agencies attended portions of the meeting as observers.

Several of the recommendations from the Summit are reflected in S 296, including expanding FDA authority to require manufacturer notification of shortages and market withdrawals and enhancing communication among health care providers and stakeholders in the pharmaceutical supply chain about the nature and expected duration of shortages. The groups provided input to the senators as they developed the legislation and will work towards passage of S 296 as part of ongoing efforts to implement recommendations from the Summit.
